Lower School After-care - Tuition Plus (Monthly)

Lower School Tuition Plus is offered to students needing a longer day after school on a regular basis. Two monthly plan options are available:

Tuition Plus - After-care (until 4:15PM) \$ 100/mo

After-care (until 6PM) \$ 300/mo

Lower School After-care - As-needed (Daily)

As-needed After-care is available after regular school hours until 6PM and is charged on an as-needed, daily basis if Tuition Plus Plan is not chosen.

K - 12 BUSINESS POLICIES

Northwood Academy serves over 1,000 children and their families. We have, since 1978, developed principles, policies, and business practices that, when administered consistently, permit our fees to remain among the lowest in the private school community, yet permit our service to advance its reputation among the very best in the community.

The School Board has approved the following business policies for Northwood Academy's Lower and Upper School:

Enrollment Fee. This non-refundable fee is paid to finalize enrollment.

Technology Fee. This non-refundable fee is paid before the 1st day of school.

Campus Security Fee. This non-refundable fee is billed in August and may be paid in two installments, due in September and January.

Tuition. Tuition payment plans are offered through FACTS. Tuition is due on the 20^{th} of each month. A grace period, through the last day of the month, may be requested.

Tuition Plus After-School Care. Lower School students, needing regular after-school childcare, may add a monthly payment plan option to the school-day tuition that meets the family's schedule and needs.

Incidental Fees. Incidental fees for as-needed childcare and food service are added to the student account and are paid monthly (on the 15th). Incidental fees are also for extra-curricular activities (e. g., field trips, athletic team participation, clubs, etc.).

Late Fees, etc. Declined FACTS payments and past due balances are subject to a 10% late fee assessment. FACTS also assesses a fee for declined payment processing. Payments will be applied to past due charges first. Student accounts are to be paid current before admission, after the semester / Christmas break, and before participation in year-end events (graduation, etc.). Services may be suspended for students with a past due balance.

An after-hours fee will be charged for after-school childcare service provided beyond the scheduled hours at \$1 per minute.

Special Payment Arrangements. Circumstances arise which occasionally require an adjustment from the normal payment policies. For consideration, email the Student Account Manager (accounts@northwoodacademy.com) with a brief description of these circumstances and a proposed solution. The request, the family payment history, and the proposed solution will be forwarded for consideration/approval, and the family will be notified of the decision.

Financial Assistance. Limited financial assistance is available to families of enrolled 1st - 12th grade students who meet income guidelines established annually by the School Board. Eligibility is limited to enrolled students who are in good standing academically (eligible for promotion), behaviorally (no disciplinary suspensions), and financially.

Family Discount. For families with 3 or more enrolled (Nursery–12th grade) children, a 25% K-12 tuition discount is available to the 3rd (and any additional) enrolled K-12 student. The discount will be applied beginning with the lowest K-12 grade level.

PRE-SCHOOL BUSINESS POLICIES

Pre-school or Nursery Fee plans are paid in ten or twelve equal, monthly installments, and are auto drafted on the 1st of each month. Discounts for holidays/daily absences are not offered. The Pre-school closes for Christmas week, and for the transition days between Summer and the School Year, per the Pre-school calendar.

Summer Weekly Fees are paid on Friday prior to the week of childcare services. A week's vacation is offered each Summer; discounts for holidays/daily absences are not offered.

Late fees, etc.

Declined FACTS payments and past due balances are subject to a 10% late fee assessment. FACTS also assesses a fee for declined payment processing. Payments will be applied to past due charges first. Service may be suspended for students with a past due balance.

An after-hours fee will be charged for service provided beyond the scheduled hours at a rate of \$1 per minute.
